The Irish Building Control Institute is pleased to present the IBCI Building Control Conference, 2009. The Conference will afford an opportunity for those involved in Building Control throughout Ireland to network with their colleagues and receive an update on current developments.

The Conference will be held over two days in the **Slieve Russell Hotel, Ballyconnell, Co Cavan**. Lunch and refreshments will be provided on both days, with the Conference Dinner on the Wednesday evening. A **Trade Exhibition** will also be held in conjunction with the Conference.

Day 1 will include an update on the Building Control legislation and procedures. This will be followed by a talk on energy efficiency and renewable technologies followed by an outline of the Acceptable Construction details for Part L.

After lunch we have a presentation on the role of the DoEHLG inspectorate followed by what we hope will be a lively soapbox and question time. Delegates then depart by bus for site visits to Quinn plants in Derrylin and Ballyconnell.

Delegates must confirm availability for site plant visits on both days at registration. PPE – Hard hats, site boots and high viz jacket/singlet required. Please bring your own to the Conference if possible

Day 2 commences with papers on sustainable developments and an introduction to the new fire code BS 9999. The final session deals with timber frame construction and detailing and concludes with a presentation on concrete forms of construction.
