IBCI Conference 2010

The Irish Building Control Institute is pleased to present the IBCI Building Control Conference, 2010. The Conference will afford an opportunity for those involved in Building Control throughout Ireland to network with their colleagues and receive an update on current developments.

The Conference will be held over two days in the **Slieve Russell Hotel, Ballyconnell, Co Cavan**. Lunch and refreshments will be provided on both days, with the Conference Dinner on the Wednesday evening. A **Trade Exhibition** will also be held in conjunction with the Conference.

Day 1 will include an update on the Building Control legislation and procedures. This will be followed by a talk on Disabled Access Certification and then a lively paper on sustainable development.

After lunch we have a presentation on disability awareness training followed by what we hope will be a lively soapbox and question time. Delegates then depart by bus for site visits to Quinn plants in Derrylin and Ballyconnell.

Day 2 commences with papers on site suitability for wastewater treatment followed by fire design case study and introduction to the Euro codes. The final session deals with new procedures in Fire departments with the new Building Control Act and concludes with an outline of what is required for BER's for non-domestic developments.
