Day 1 will include an update on the Building Control legislation and procedures. This will be followed by the latest information on Radon. The morning session finishes with a look at the new Part M 2010 document "Access and Use"

After lunch we have devoted most of the session to Disabled Access Certification. We will see this from the perspective of Local Authorities and the private sector with the implications of the new Part M 2010 followed by a discussion/questions on this whole subject. Finally we have hopefully a lively soapbox if anyone wants to raise any relevant issues.

Day 2 commences with paper on sustainable development and renewables followed by developments in residential fire safety. The final session deals with Universal design and the totally revised NDA publication Building for Everyone followed by the role of the Engineer in Building Control and Registration
